## 14. General Summary of Function/Purpose of Position

The Registered Dietitian in this position is a senior worker functioning with a full range of assignments at an advanced practice level and serves as the advanced level nutrition therapist. This position functions as the recognized resource for the treatment team for the assigned units. Participating as an active member of treatment team, medical nutrition therapy is provided to assigned patients. Therapy is individualized and coordinated with families and/or subsequent care givers and food service personnel. A significant number of specialized food service, safety, and consultation tasks are performed routinely; consultation and direction are given to each other health care professionals and community agencies. Assignments are generally complex, performed with minimal guidelines, and performed independently.

This is a drug and alcohol tested (DART) position under the criteria provided in the collective bargaining unit agreement, as the incumbent has regular and direct contact with hospital patients.

## Duty 1

General Summary: Percentage: 20

Completes assessments of nutritional status to identify appropriate Medical Nutrition Therapy required. Assigns and documents appropriate nutrition priority level.

## Individual tasks related to the duty:

- Interviews patient and/or significant others
- Interprets nutritionally significant laboratory values
- Interprets anthropometric measurements
- Evaluates clinical, social and psychological data
- Integrates all of the above into plan for medical nutrition therapy
- Develops and maintains database for computer usage for department
- Utilizes data to provide patient care information and reports

## Duty 2

General Summary: Percentage: 20

Develops person centered nutrition care plan according to needs identified in the assessment. Provides medical nutrition therapy according to patient needs and the most current standards of professional practice.

#### Individual tasks related to the duty:

- · Develops detailed nutrition care plans with specific goals, interventions and outcome measures
- Modifies diet for appropriate food, nutrient, fluid intake- directs food service and nursing personnel regarding same
- · Verifies and evaluates intake-calculating nutrients consumed and comparing with calculated needs
- Incorporates current research and practice methods to evaluate effectiveness of therapy
- Attends health care team meetings providing consultation to physicians, nurses, rehabilitation therapists and other staff

## Duty 3

General Summary: Percentage: 20

Evaluates, documents and adjusts nutrition therapy delivery

## Individual tasks related to the duty:

- Observes patient intake and calculates same
- Adjusts meal patterns, food preparation and delivery
- Determines need for specialized medical food products
- Orders food and medical nutrition products for individual patient needs
- Inspects food preparation and service
- Develops solutions to problems and implements as necessary

#### Duty 4

General Summary: Percentage: 25

Provides education and skill development related to medical nutrition therapy

## Individual tasks related to the duty:

- Evaluates need for self care skills related to nutrition therapy
- Develops educational plans and programs
- Develops appropriate materials based on target population knowledge, education, skills and abilities
- Incorporates current research and practice methods
- Evaluates effectiveness of education

## Duty 5

General Summary:	Percentage:	5

Develops and implements performance improvement activities for medical nutrition therapy to ensure efficient, effective service delivery

## Individual tasks related to the duty:

- Utilizes current research to develop performance improvement and clinical outcome studies
- Ensures objective data collection, evaluates same
- Identifies areas for improvement and collaborates with nutrition therapy team to resolve problems
- Develops solutions to problems and implements same
- Evaluates effectiveness of problem resolution

#### Duty 6

General Summary: Percentage: 10

- As a collaborative with other team members works to implement the comprehensive treatment plan as a means to improve the patient's condition
- Is familiar with the knowledge, skills and abilities of other disciplines as represented by other team members and utilizes those skills to enhance nutrition therapy
- Identifies education needs of the patient and/or caregiver that when met will assist the patient in maintaining wellness outside the hospital
- Acts as an advocate for the patient relative to food and nutrition needs
- Assures patient confidentiality

- Determination of medical nutrition treatment for patients, including nutrients required and route of administration
- Determination of patient care priorities
- Determination of patient and staff food service needs
- Determination of patient, staff and family skill needs
- The above require exquisite independent judgment and must be related to outside regulatory agency guidelines. These affect patients, physicians, nurses and other professional staff and community agencies involved with post hospital placement. They affect the operational budget and hospital accreditation status.

This position is classified as requiring sedentary to light physical effort. Physical activities typically include sitting, standing, walking, reaching, handling, talking, hearing, near acuity vision and far acuity vision. Environmental conditions involve working in close proximity to psychiatric patients who may also have contagious diseases who are aggressive and known to strike out or attempt escape. Frequent exposure to hot/humid environment in kitchen area and slippery conditions.
