#### 14. General Summary of Function/Purpose of Position

This position troubleshoots, evaluates and inspects electrical and mechanical systems including specialized equipment in state facilities, pump stations, and rest areas.

The duties of this position require the incumbent to operate a vehicle or vehicle/trailer combination with a Gross Vehicle Weight Rating (GVWR) of 26,001 pounds or more (e.g., large utility truck, aerial devices, crane trucks).

15. Please describe the assigned duties, percent of time spent performing each duty, and what is done to complete each duty.

#### Duty 1

General Summary: Percentage: 75

Troubleshoot, inspect and evaluate electrical/mechanical systems. Perform routine, reactive, preventive, emergency maintenance and repairs to pumphouses (storm water pump stations) and signal controllers alongside interstate highways and state trunk lines, garages, rest areas, welcome centers, and other state facilities May include permit required confined space entry. This duty requires operating a vehicle or vehicle/trailer combination with a GVWR of 26,001 pounds or more.

#### Individual tasks related to the duty:

- Troubleshoot, inspect and evaluate electrical equipment that includes 120-volt single phase to 960-volt 3 phase systems to ensure that it operates efficiently and safely; determine whether equipment and new installations meet requirement of the National Electrical Code.
- Perform routine inspections that includes testing running pumps, checking trash racks for debris, and general inspection of grounds.
- Perform on-site troubleshooting of failures of pump/electrical failures.
- Restore power to pump houses by use of a generator during emergencies to clear roadway of standing water.
- Build and install new signal controllers.
- Measure, cut, bend, thread, assemble, and install electrical conduit, fittings, receptacles, transformers, fixtures, devices, outlet boxes and switch boards.
- Perform annual maintenance on electrical equipment.
- Operate specialized maintenance equipment such as, but not limited to backhoe, excavator, hi-low, loader, vac-truck, small crane, aerial
  equipment, etc.
- Operate CDL required equipment such as, but not limited to large dumps, aerial devices, and crane trucks.

- Install, service and repair the following but not limited to heaters, coolers, fans, air compressors, air conditioning units, chemical water treatment
  systems, water softeners, masonry, plumbing, water heaters, circulating pumps, sump pumps, floats, light bulbs, windows, roofs, general building
  maintenance and fabricate parts as needed.
- Maintenance, inspection and minor repair of facility and grounds such as, but not limited to lawn care, including shrubs and trees, repair/replace broken picnic tables, unplug plugged drains, etc..

Be available outside normal working hours for maintenance/emergency operations, in all weather conditions. Working on roadway in high traffic areas, working in permit entry confined spaces, working with chemicals, working with electrical equipment, and the wearing of personal protective equipment. Manual labor involves lifting and carrying heavy tools and materials. Also requires climbing ladders, bending, twisting, and stooping. This position is required to operate vehicle or a vehicle/trailer combination with a GVWR of 26,001 pounds or more.
