14. General Summary of Function/Purpose of Position

The function and purpose of this position is to serve as a financial specialist in the department to provide forensic financial review and analysis of financial records in complex investigations and prosecutions under the Cannabis Regulatory Authority MOU. The position entails working independently in a high-volume environment to plan, organize and perform the work as assigned. The position also requires the ability to work with attorneys and investigators to answer questions and explain work product, and to provide clear and accurate expert testimony in court concerning work product.

Duty 1

General Summary: Percentage: 70

Coordinate and perform complex financial investigations, special projects, analyses and/or assignments as directed by the First Assistant and Division Chief.

Individual tasks related to the duty:

- Determines parameters of assignment by review of that being requested and/or material being provided.
- · Reviews evidence in Cannabis financial investigations.
- Examines financial records, including but not limited to those records obtained from financial institutions, state entities, and businesses, to determine whether indicia of criminal activity exists.
- Performs complex forensic financial analyses in financial criminal and civil forfeiture cases, special projects, and assignments.
- Conducts forensic audits of the suspect individual and/or suspect business's financial records.
- Requests investigative assistance as needed, if complainant or suspect dictates the need for additional information and/or suspect interviews.
- Produces investigation reports and financial analysis documenting the results of the investigation/analysis.
- Provides reports in visual formats such as pie charts, bar graphs, or similar formats as requested by attorneys or investigators.

Duty 2

General Summary: Percentage: 20

Determine restitution amounts in Cannabis cases and other financial crime cases.

Individual tasks related to the duty:

- Verify State of Michigan losses through analysis of the defendant's financial records that corroborate alleged sales, request investigators to obtain additional information as necessary and examine relevant financial documents or other materials as necessary.
- Present State of Michigan restitution amounts at sentencing hearing through reports summarizing findings and expert testimony. 75% of this position's time spent on each duty will be devoted to Cannabis cases handled or managed by the Financial Crimes Division, and 25% of this position's time will be devoted to other complex financial crimes cases being investigated and prosecuted by other divisions within the Criminal Justice Bureau.

Duty 3

General Summary: Percentage: 10

Provides clear and accurate expert testimony and evidence in state court in complex Cannabis cases and in other financial crime cases.

Individual tasks related to the duty:

- Summarize findings of forensic financial analysis into easily understood documents that can be admitted into evidence in court.
- Present findings of forensic financial analysis as an expert witness in a professional manner, and in a manner that is easily understandable to individuals who have limited or no background in the fields of finances or accounting. 75% of this position's time spent on each duty will be devoted to Cannabis cases handled or managed by the Financial Crimes Division, and 25% of this position's time will be devoted to other complex financial crimes cases being investigated and prosecuted by other divisions within the Criminal Justice Bureau.

16. Describe the types of decisions made independently in this position and tell who or what is affected by those decisions.

Provide accurate fact and opinion evidence in court proceedings. Review of investigations for final recommendations.

Final decisions relative to civil or criminal case investigations, prosecutions, or case closure. Final recommendations re State of Michigan restitution allocation.

Job duties are generally performed in an office and require the use of general office equipment.
