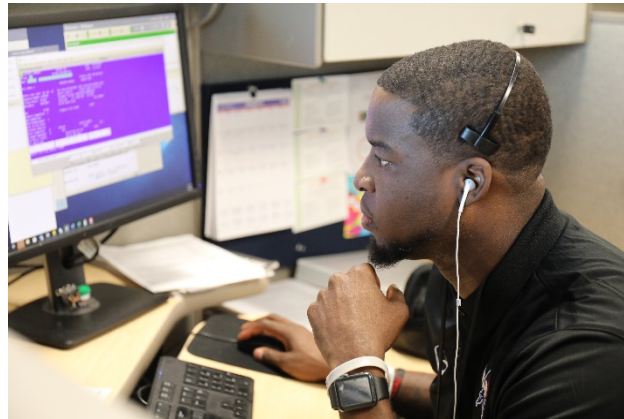


Communication and collaboration are important components to our foundation. Treasury's Employee Resource Groups, Mentoring Programs, and Employee and Supervisor Development Programs are designed to facilitate both collaboration and communication between employees. Treasury employees have access to news and resources on The Vault, our intranet site. That is a great place to learn about the many ways Treasury employees care about our communities, such as our participation in

charitable giving activities, blood drives, fundraising events and more.

Treasury also offers important insurance benefits (health, dental, vision, life insurance, long-term disability) with options to purchase additional life insurance and long-term care insurance. Certain legal services are also available.

Financial benefits include: non-taxable flexible spending accounts; automatic 4% employer contribution into your 401k and up to 5% of employee contributions matched (fully vested in 4 years); paid annual and sick leave to cover time away from work; and longevity payments after completing 6 years of employment.



An exciting new benefit is up to 12 weeks of paid parental leave for birth or adoption of a child after completing initial probationary period! Family Medical Leave Act protections are also available for certain family or medical situations.

Free parking is available for Treasury employees who work at the Operations Center in Dimondale, MI. Pre-tax parking may be available at other Treasury work locations. If you like to ride your bicycle to work, the City of Lansing has bike lockers reserved for State Employees near the Van Wagoner and Austin Buildings in downtown Lansing. Finally, and perhaps even more relevant today, you may also be able to work a flexible schedule and/or telecommute, depending on the position.
