Duty 1

General Summary: Percentage: 80

Supervise, train and assign work to detailed prisoner workers on a daily basis.

Individual tasks related to the duty:

- Provides training in the proper methods to carry out maintenance assignments.
- Assigns preventative maintenance and repairs of building to prisoner crews.
- Inspects any repairs, installation, and maintenance performed by inmate to ensure completion.

Duty 2

General Summary: Percentage: 10

Orders supplies and repair parts, maintains prisoner payroll, maintains required institutional records and daily logs.

Individual tasks related to the duty:

- Makes contact with vendors to price and purchase repairs parts and services.
- Completes procurement requests.
- Completes prisoner payroll forms.
- Completes tool logs.
- Completes gate manifests.
- Completes vehicle travel logs.
- Completes required training.

Duty 3

General Summary: Percentage: 10

Assists other staff with assigned work or projects.

Individual tasks related to the duty:

- Installs, services, and repairs electric motors, heaters, coolers, refrigerators, and other related equipment.
- Fabricates, assembles, and tests parts as needed, such as various pumps, valves, laboratory
 equipment, heaters, compressors, experimental fire equipment, and other mechanical system
 parts.
- Performs grounds and maintenance work.
- Maintains equipment and systems.

16. Describe the types of decisions made independently in this position and tell who or what is affected by those decisions.

Makes decisions regarding how equipment or systems are going to be repaired or maintained. These decisions affect costs, quality of work, health and sanitary issues and whether they meet required codes and regulations.

Repairs that require a permit need supervisor approval. Out of state travel. Deviation from department policies and procedures need supervisor approval.

This position requires lifting up to 80 lbs., bending, kneeling, standing and walking. Environmental conditions include working outside in all types of weather, contact with human waste, fumes, chemicals, and other hazards. Daily contact with prisoners at a level 2 correctional facility.
