14. General Summary of Function/Purpose of Position

Oversee and assist the electrical needs of a 1108 bed level I secure correctional facility. Direct operations of the electrical shop which includes the prisoner work crews. Maintain and repair electrical service, communication and security systems for the facility. New electrical installations. Inspect and ensure all work complies with state and local regulations and applicable standards.

Duty 1

General Summary:

Percentage: 65

Directs, performs and assists staff and prisoner work crews in all phases of electrical installations, maintenance and remodeling.

Individual tasks related to the duty:

Supervise prisoner work crews.

- Ensure safety of workers and staff.
- Work with supervision on all projects.
- Installation of equipment and fixtures.
- Compliance with all state and local codes.
- Tool, caustic and key control.

Duty 2

General Summary:

Percentage: 20

Maintain emergency power sources, communication and institutional security systems. Install equipment and parts when needed. Test and check all electrical systems on a regular basis.

Individual tasks related to the duty:

Provide preventive maintenance to power sources, communication and institutional security systems.

- Repair equipment and fixtures.
- Perform diagnostic operations.

Duty 3

General Summary:

Percentage: 10

Repair equipment. Repair lights, kitchen equipment and perimeter lighting.

Individual tasks related to the duty:

Receive, review and sign off on completed work orders

- Diagnose the problem.
- Determine materials and tools needed to accomplish the repair.
- Issue materials from stock inventory
- Direct the work of prisoners

Duty 4

General Summary:

Percentage: 5

Ordering, record keeping and paperwork. Other duties as assigned.

Individual tasks related to the duty:

Process prisoner payroll on a monthly basis.

- Obtain estimates and prepare requisitions to purchase necessary parts, tools, etc to perform job duties.
- Process prisoner work reports.
- Prepare and submit progress reports.
- Prepare tool reports.
- Maintain vehicle log
- Order parts as needed and track the orders

16. Describe the types of decisions made independently in this position and tell who or what is affected by those decisions.

Assesses work for compliance with applicable building and health codes. Determines what materials are needed to perform duties. Determines prisoner work assignments. Supervises prisoner work crews ensuring conformance with all institutional and departmental rules and procedures. Makes decisions while performing job duties on a daily basis that will affect the overall prison population and the security of the facility.

17. Describe the types of decisions that require the supervisor's review.

Priorities. Safety. Work schedules. Expenditure of funds. Operational changes that effect the security and safety of the facility. Required permits.

18. What kind of physical effort is used to perform this job? What environmental conditions in this position physically exposed to on the job? Indicate the amount of time and intensity of each activity and condition. Refer to instructions.

Standing, sitting, climbing, stooping, reaching, writing and communication on a continuous basis. Wet cold, hot, noisy and smokey exposure intermittently. Working from lift platforms and scaffold. Face to face prisoner contact on a continual basis. This position has regular unsupervised access to and direct contact with prisoners.
