14. General Summary of Function/Purpose of Position

The Animal Industry Division (AID) of the Michigan Department of Agriculture and Rural Development is committed to protect, regulate, and promote animal health. In doing so Public Health, Animal Health and Well-Being, and Animal Industries are safeguarded through collaborative efforts and implementation of effective programs. The purpose of this position is to protect human and animal health, to promote and protect Michigan animal industries, and to assure the public of quality, healthy animals, including food animals, equine, cervidae, exotic animals, and companion animals.

Counties: Gratiot, Genesee, Oakland, Saginaw, Bay, Thumb region or other areas as needed.

This position is required to follow established standard operating procedures and meet quality, quantity, and timeliness standards for assigned work.

Duty 1

General Summary of Duty 1 % of Time 35

Conduct inspections of livestock markets, animal shelters, large-scale dog breeding kennels, dog pounds, horse sales, fairs and exhibitions, rendering plants, transfer stations, livestock dealer trucks and records, aquaculture facilities, and poultry composting facilities and other facilities licensed and regulated by the Animal Industry Division.

Individual tasks related to the duty.

- Conduct routine announced and unannounced inspections of licensed entities.
- Assure that licensed entities in assigned territory are in compliance with appropriate laws and regulations.
- Examine animals for health status and signs of contagious or communicable disease.
- Complete quality inspection reports, special reports, and photo reports in a timely manner.
- Provide education and guidance to correct non-compliant situations.
- Collect evidence, write citations, and pursue administrative procedures or criminal prosecution if appropriate. This includes helping program managers and the compliance unit to prepare for hearings and trials. It also may involve appearing in court as an expert witness.
- Keep supervisor/program manager/State Veterinarian informed of problem situations.
- Conduct quality pre-licensing inspections in a timely manner.
- Consult with and meet with owners/managers of facilities and private practice veterinarians.

Duty 2

General Summary of Duty 2 % of Time 35

Investigate traces and or test livestock for tuberculosis; primarily cattle, goats, and sometimes deer, elk, or bison. Testing is done pursuant to PA 466 of 1988, Amended (Animal Industry Act). Caudal fold and comparative cervical testing and blood-based testing will be performed.

Individual tasks related to the duty.

- Locate livestock herds to trace and/or test as assigned. (Exposed traces, source traces, secondary testing, etc.)
- Contact producers to arrange for tuberculosis testing.
- Assemble necessary equipment and supplies.
- Coordinate human resources for assistance by working with supervisor.
- Corral and restrain animals; identify animals.
- Complete TB testing according to published standards.
- Complete appropriate paperwork and write reports of quality and in a timely manner.
- Assure that equipment and clothing are disinfected between farm visits.
- Issue/remove quarantines as appropriate.

Duty 3

General Summary of Duty 3 % of Time 5

Investigate animal disease, toxicity, or drugs residue problems, as assigned. This may involve emergency situations.

Individual tasks related to the duty.

- Visit farms to obtain history and conduct epidemiological investigations per program manager recommendations.
- Issue and release quarantines, as appropriate.
- Consult with MDARD supervisor/program manager/State Veterinarian about status of situation and resources needed to proceed with investigation.
- Review regulatory procedures and disease control procedures with animal owners and provide information about the disease and toxicity.
- Work cooperatively with private practice veterinarians, USDA veterinarians, Michigan State University personnel, local MSU-E representatives, and local law enforcement and government officials.
- Write quality detailed reports in a timely manner.
- Collect evidence, issue citations, or pursue criminal prosecution, as appropriate. This involves helping
 program managers and the compliance unit to prepare for hearings and trials. It also may involve
 appearing in court as an expert witness.
- Euthanasia and disposition of animals (sometimes entire herds or flocks) in some situations.
- Clean and disinfect premises in some situations.
- FDA credentialing and training will be required upon hiring for tissue drug residue investigations.

Duty 4

General Summary of Duty 4 % of Time <u>5</u>

Test animals as assigned for reportable diseases and toxicities. This may include biopsies, performing necropsies, tissue collection, blood collection, injections, etc. Proper animal identification, correct submission of samples, and completion of paperwork are essential.

Individual tasks related to the duty.

- Restrain animals including, but not limited to, ruminants, equine, ratites, poultry, swine, exotic animals, and companion animals. This may involve the use of restraint equipment such as cattle chutes, halters, twitches, or snare.
- Identify animals by species, breed, weight, height, age, gender, color, markings, tab numbers, tattoos, brands, and microchip identification. Apply tags, tattoos, and brands.
- Collect blood, milk or tissue samples, inject tuberculin; read tuberculin skin test results. Collection of tissue samples may involve surgical procedures with appropriate analgesic agents and aseptic technique.
- Package and transport samples.
- Fill out test charts and write quality reports in a timely manner.
- Observe appropriate disease control procedures to prevent spreading disease to other animals or locations.

Duty 5

General Summary of Duty 5 % of Time 5

Investigate complaints received from the public involving primarily animal health, animal care, failure to bury animals, and issues concerning regulated facilities. Some complaints are investigated jointly with personnel from other divisions in MDARD, or with personnel from local governmental or investigatory agencies.

- Receive complaints directly from the public, from the Michigan Department of Agriculture office(s), and from other local, state, and/or federal agencies.
- Investigate complaints promptly after work order is compiled by program manager and assigned by field staff supervisor. This may involve visiting and interviewing complainant, subject of the complaint, neighbors, or witnesses. This may involve taking affidavits.
- Identify program issues of non-compliance and initiate steps for correction.
- Notify supervisor/program manager/State Veterinarian of situations where substantial violations exist or where there are media or legislative concerns.
- Write quality reports in a timely manner.
- Collect evidence, write citations, pursue administrative enforcement procedures, or pursue criminal
 prosecution, as appropriate. This involves assisting program managers and the compliance unit in preparing
 for hearings and trials. It also may involve appearing in court as an expert witness.

Duty 6

General Summary of Duty 6 % of Time 5

Monitor inter- and intrastate movement of animals pursuant to Act No. 466, P.A. 1988, as amended (Animal Industry Act); Regulation 112 (Importation of Dogs); and Act No. 358, P.A. 1994 (Ferrets) and the Animal Disease Traceability rule.

Individual tasks related to the duty.

- Based on complaint or request from supervisor/program manager/State Veterinarian, check health certificates and test papers on animals. This may occur anywhere animals are found.
- Educate animal owners about requirements for movement of animals.
- Issue/release quarantines, as appropriate.
- Write detailed reports of satisfactory quality and in a timely manner.

Duty 7

General Summary of Duty 7 % of Time 5

Write reports; maintain records, logs, and files; keep information up to date and submit required documents in a timely manner. Documents include but are not limited to, itineraries, activity reports, travel vouchers, telephone logs, inspection reports, complaint investigation, and special reports.

Individual tasks related to the duty.

- Utilize computer and other technological devices to generate reports.
- Submit quality documents within a timely manner.
- Maintain organized filing system at workstation.

Needles, syringes, blood collection tubes, and other testing supplies are routinely handled as well as some hazardous chemicals in performing assigned work. There may be exposure to zoonotic diseases. Work conditions may be wet, cold, hot, noisy, and dusty. Substantial odors may be present. Work conditions in some barns may be closed, cramped, and dark.
