ASSISTANT EXAMINER

- Present findings and recommendations to Examiner in Charge (EIC) including submission of complete and accurate workpapers and narratives.

EXAMINER-IN-CHARGE

Individual tasks related to the duty:

- Serves as an examiner-in-charge (EIC) of examination and investigations of nonproblem, noncomplex, non-depository financial institutions and mortgage loan originators listed in Item 14 to determine if licensees are operating in accordance with state and federal statutes in a safe and sound manner.
- Responsibility for presentation of finding and recommendations to the institutions' CEO and executives and for submitting a completed report of examinations or investigations to his/her supervisor along with a comprehensive set of workpapers, for each examination or investigation.

Field examiners are temporarily assigned to various locations throughout the country, but mainly in Michigan, for one or two days up to several weeks. Their duties and tasks are performed in temporary office facilities provided by the financial institution being examined and include considerable sitting, occasional standing and walking, limited lifting, periodic microcomputer usage and normal office routines. Position requires daily in-state travel by automobile and out-of-state travel usually by air. Overnight travel is required.

The function of the Office of Consumer Finance is to serve as the primary regulator of state-licensed non-depository financial institutions, and mortgage loan originators, as required by the statutes listed in Item 14. Position performs as assisting examiner or Examiner in Charge in the gathering, analysis, and evaluation of source data obtained from companies and individuals engaged in activity regulated by the statutes listed in Item 14.

Relevant industry experience varies by position and may include: financial institution commercial credit analysis/underwriting, commercial lending, loan review, audit, compliance, and risk management; or insurance accounting, internal/external audit, actuarial and risk management; as well as oversight of such functions.
